Residential Direct Care Program

Kadima's Residential Direct Care Program has three licensed homes staffed 24 hours a day, and thirteen homes that are staffed between 8 and 24 hours per day. Staffing services include assistance with bathing, eating, dressing, transportation, medication delivery, shopping, monitoring/support, transportation to medical appointments, and medication set-up. With residential services; prepared meals, housekeeping assistance, utilities, phone, cable and internet are also included.

Community Living Support and Case Management Program

Kadima's Community Living Support and Case Management Program provides services to clients that live in the community as well as eleven properties managed by Kadima. Services are provided on an as needed basis. Services include: transportation, medication delivery, shopping, monitoring/support, transportation to medical appointments, and medication set-up. The clients that are living in a Kadima owned property also receive residential services which includes housekeeping assistance, utilities, phone cable and internet.

Clinical Services Program

Kadima's clinical services program provides the opportunity for clients to meet with masters level social workers for individual, family and group therapy. These services are provided to clients of all ages.
